1. The Seller warrants that the above referenced puppy is a purebred Labrador Retriever, able to be registered with the American Kennel Club, and that registration papers have been provided to the Buyer as of the date of the completed purchase.
2. The Seller guarantees that the above referenced puppy is in good health on the date of delivery, and is free of hereditary defects to the best of her knowledge, and is the product of a planned breeding between the OFA, CERF tested adult dogs listed above. Before release to Buyer, puppy will be de-wormed if indicated, and have first puppy vaccinations (record of vaccination history is supplied). For puppies picked up by Buyer. Buyer agrees to have the puppy examined by a licensed veterinarian within 2 days (not including weekends and holidays) of receipt of the puppy. If the Buyer's veterinarian determines that this puppy is ill, Seller must be notified immediately and the puppy, its registration papers and a written statement by the veterinarian must be returned to the Seller within 24 hours for a full refund or replacement puppy. The Seller does not assume any liability for any injury to said puppy after purchase date or for any veterinary costs, even if the puppy is left in the care of the Seller.
3. The Buyer shall maintain the puppy in good health, including adherence to a regular immunization schedule, heart worm preventative, flea and tick preventative if warranted, nutritious diet to maintain a healthy weight, professional veterinary care as needed, a clean, safe environment including proper shelter (with protection from the winter and summer temperatures), prompt medical attention if puppy shows signs of illness or injury, an exercise routine in accordance with the age of the puppy, and human companionship. If this puppy/dog is used heavily for field trialing, open obedience, hunting, jogging or any other strenuous activity prior to the puppy's physical maturity, environmentally induced hip dysplasia and other joint problems may develop.
4. The Seller has taken great care to ensure the health and soundness of this puppy, and is selling said puppy as a pet. For the continued optimal health of this puppy, the Buyer agrees that this puppy will not be bred and will be spayed or neutered at physical maturity/24 months of age and is purchasing this puppy with AKC limited registration.
5. If at any time in its life the puppy is to be sold or given away, the Buyer or his estate (in the event of the Buyer's death), shall so notify the Seller and give the Seller first option to reclaim the puppy/dog at no cost to the Seller or allow Seller to assist in proper placement at the discretion of the Seller. Furthermore, the Buyer agrees to notify Seller of any changes of address during the puppy's lifetime.

6. The Buyer shall not sell this puppy to any individual or establishment in the business of buying and selling puppies for profit.

7. Buyer agrees that Seller has the right to repossess said puppy/dog upon evidence of neglect or abuse.

8. If the Buyer breaches this contract in any way and a law suit results, all costs, including the legal fees of the Seller will be the responsibility of the Buyer. Any issues requiring legal settlement will be litigated in Ingham County, MI.

This agreement is made and signed by both parties to ensure the well being and protection of this puppy. If the Buyer breaches any part of this Agreement, the Seller is released from any obligation under this agreement and has the right to repossess the puppy at no cost to the Seller.
